Thank you for the telephone call the other day where you told me that Farmers has agreed to extend coverage to Mr. Meyers for no-fault benefits related to the January 11, 2008 motor vehicle collision.

**WAGE LOSS**

Mr. Meyers was employed by Auto Alliance International as an auto assembler. He earned \$28.585/hr working 40 hours per week. Obviously, due to the severity of his injuries, Mr. Meyers has yet been unable to resume his prior employment. Thus, Mr. Meyers wage loss claim is as follows:

Rate: \$28.585 per hour \* 85%  
Weekly hrs: 40 hrs  
Dates: January 11, 2009 to September 27, 2009 (makes it an even 37 weeks)  
Owing: \$35,959.93

**ATTENDANT CARE / REPLACEMENT SERVICES**

The severity of Mr. Meyer's injuries has made him unable to perform household chores that he performed prior to the truck hitting him. Following his discharge from the hospital at University of Michigan, he was forced to move in with his nephew, Derrick Meyers who now has to perform all household tasks as well as provide personal attendant care services.

Attendant care rate: \$21.00  
Hours of AC through Aug 09 12,648  
Owing: \$ 265,608.00

Replacement service rate: \$20.00  
Days through Aug 09: 526 days  
Owing: \$ 10,520.00
